Wrestlers are expected to report for weigh-in without bandages or any other skin coverings. IHSA Skin Condition Forms are required for all wrestlers with visible skin problems.

The scales will be open from 6:30 - 7:30am for wrestlers to check their weight. At 7:30am we will weigh-in by team in the order given to you upon your arrival. We will weigh-in in the Auditorium. Directions will be given at the check in. We will weigh-in by teams and therefore, ALL TEAMS MUST BE PRESENT AT 7:30AM FOR THE OFFICIAL WEIGH-INS. Scales will officially close after the last team has weighed-in.

There will be a one pound weight allowance for Tuesday, December 23rd, 2008.

Submitting Rosters: Coaches are required to submit individual entries via the Internet. Simply go to <http://www.ILWrestle.com>, go to "Dvorak Memorial", click on the link for "Enter Rosters Here", fill out the form, and click SUBMIT.

Please include up-to-date varsity records and other information which may assist tournament managers in separating out the better wrestlers in each bracket. For your convenience the seeding criteria is included. A verification of your entries will be emailed to the address provided on the form. There may be ONLY ONE ENTRY PER WEIGHT.

- Seeding Criteria: Wrestlers will be seeded according to the following criteria:
1. Returning State Champ (AA)
 2. Returning State Runner-up (AA)
 3. Returning State Champ (A)
 4. Returning State Place Finisher
 5. Returning State Qualifier
 6. Returning Place Winner (1st - 3rd) Dvorak Tourney
 7. Wrestler must have at least 7 matches
 8. Wrestler must have at least a .500 record
 9. Record by percentage
 10. We will attempt to seed all wrestlers. 1vs32, 2vs31, 3vs30 etc.
- Team Scoring: In accordance with the National Federation of High Schools Rules.
All byes will be scored as forfeits.
- Awards: Trophies will be awarded to 1st thru 6th place teams. A plaque will be awarded to the tournament's Most Valuable Wrestler as voted on by the coaches. An additional plaque will be awarded to the wrestler with the most pins in the least amount of time. In addition, individuals will receive trophies for 1st thru 6th, and medals for 7th and 8th.
- Trainer: We will have 4 certified athletic trainers, a physical therapist, and two student athletic trainers on duty throughout the tournament.
- Pass Gate: Enclosed is a pass gate roster which must be faxed no later than Tuesday, December 16th. Each school will be allowed a maximum of 6 persons on their pass list.
- In order to be on the main floor during the tournament, wrestlers must be in uniform; coaches and statisticians must be wearing a floor pass. Each school will be issued four floor passes.
- Buses: School buses should park in the West end of the parking lot.
- Locker Rooms: Signs will be posted to the locker rooms. Towels will not be provided. Wrestlers should bring their own lock and towels. Remind all your wrestlers not to leave their valuables in their lockers. Harlem High School will not be responsible for lost or stolen items.
